Table 1 - CVEnumRevRecallAction Values

CVEnumRevRecallAction Values	
Value	Documentation
PURGE	Immediately remove and destroy all copies of the revision of the product that has been revised or recalled.
RETAIN_WARN	Retain the existing copies of the revision of the product but indicate that it is not the latest revision.
RETAIN_HIDE	Retain the existing copies of the revision of the product but prevent access and distribution.
MANUAL_INSTRUCTION	The action to be taken as a result of the revision or recall requires manual intervention by a human to read and follow the included instructions.

Table 2 - CVEnumRevRecallType Values

CVEnumRevRecallType Values	
Value	Documentation
ADMINISTRATIVE_RECALL	Notify recipients that a product has been withdrawn due to significant but non-substantive technical, legal, or policy issues (but is not used for a FISA-compliance recall); e.g., compromise of sources and methods, identification of US person, improper classification.
ADMINISTRATIVE_REVISION	Notify recipients that a modification has been made that does not affect the substance of the original product; e.g., misspellings, typographical errors, additional recipients.
FISA_COMPLIANCE_RECALL	Notify recipients that a product has been recalled specifically for a FISA-compliance reason.
SUBSTANTIVE_RECALL	Notify recipients that a product has been withdrawn due to significant concerns about the accuracy of the information, the integrity of the source, or the soundness of the analytic judgments.
SUBSTANTIVE_REVISION	Notify recipients that a change has been made that does affect the substance of the original product but does not invalidate it; e.g., dropped words or sentences, inaccurate paragraphs or comments, minor analytic judgments.
