Chapter 1 - Introduction

1.1 - Purpose

This is an informative supplement to XML CVE Encoding Specification for ISM Country Codes and Tetragraphs (ISMCAT.CES) as a human readable document.

The membership tables are sorted alphabetically by the country code for the convenience of readers. The underlying taxonomy file has no ordering inherent to it. Similarly the document is sorted by the tetragraph's token purely for the reader's convenience.

Chapter 2 - Current Tetragraph Taxonomy Mapping

This is a mapping of the countries that have membership in each tetragraph.

Each tetragraph/token specifies classification information and whether its membership is decomposable. Decomposition in this case refers to the breaking down of the membership into its component members for the purposes of rollup. An example is decomposing FVEY into the five member countries: USA, AUS, CAN, GBR, and NZL. This decomposition allows a portion marked RELEASABLE TO USA, GBR and another portion marked RELEASABLE TO USA, FVEY to rollup to RELEASABLE TO USA, GBR. If FVEY was not decomposable the rollup would have to have been NF.
