Who May Apply

Current GS employees at the same grade as the advertised or two grades below may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- **For a cadre assignment:**
 - Current ODNI permanent cadre.
 - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual.
- A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above based on education and experience.

You are an excellent communicator, capable of crafting powerful narratives across a variety of. You are constantly learning, partnering with SMEs, writers, and leadership to develop the internal communications products. You are also a strategic thinker, exploring new ways to both tell and present information for the maximum impact. Finally, you thrive under deadlines, delivering succinct and effective products quickly.

- Research topics, conduct interviews, write news, feature and explanatory articles for ODNI publications, ODNI websites and blogs to facilitate understanding of the ODNI's mission, goals, and strategies to the ODNI and Intelligence Community workforces, respectively.
- Manage editorial calendar.
- Write and create powerful content in brand-journalism style for multiple publication mediums, including websites, blogs, social media, leadership messages and more.
- Serve as communications consultant to senior leadership at the Office of the Director National Intelligence and provides leaders and components with substantive advice and counsel on the development of communications.



- Responsible for performing work involved in establishing and maintaining mutual communication between Federal agencies and the general public, including internal or external, foreign or domestic audiences.
- Identify opportunities for ODNI senior leadership speak either virtually or in-person for events internally and externally across the Intelligence Community. Prepare read ahead materials to include agendas, bios, and talking points.
- Execute a comprehensive ODNI strategic communications plan for an assigned area of responsibility that effectively communicates the ODNI's mission, vision, and goals to a specific set of assigned stakeholders.
- Cultivate and maintain productive working relationships with staff in other communications organizations in the Intelligence Community (IC), and, as appropriate, members of the media, community leaders, policy groups, and/or concerned constituencies to provide information about ODNI mission, programs, and activities.

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. ***Applicants from within the IC must submit an application through the classified IC Joint Duty Program website.***

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
