Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade below the advertised position may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees GS-15 and one grade below may apply.



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Policy and Capabilities Directorate is focused on ensuring the IC is best postured to meet the future challenges and threats confronting our nation.

Major Duties and Responsibilities (MDRs)

- IC Human Capital (HC) follows a matrix-management approach to organization and mission. Each person has a primary supervisor and group, but participates in other office initiatives according to their skill sets and mission needs.
- Serve as the lead officer for Human Capital's Workforce Modernization team to advance the IC workforce's skills to meet the challenges of the future, with a particular initial emphasis on upskilling the IC workforce.
- Research current workforce and private sector development strategies in order to propose recommendations for IC efforts to upskill the workforce.
- Provide strategic oversight and guidance for upskilling programs that cross agency lines.
- Advocate for measures to progress the Modernize IC Learning strategy. Track and report on progress.
- Help lead the IC Training Council.
- Work with Mobility team to advance IC Competencies effort to promote tools and knowledge that identify skill strengths and gaps.
- Oversee development opportunities available to the IC that require selection and vetting by the ODNI. Work to increase transparency of these opportunities to the IC.

Mandatory and Educational Requirements

- Demonstrated superior organizational and interpersonal skills, specifically, the ability to plan strategically and manage competing priorities, the demonstrated ability to negotiate, build consensus, and work effectively in a collaborative environment, and the ability to establish and maintain professional networks across all levels of management.
- Possess superior oral and written communication skills, including the ability to clearly convey complex information and technical data to all levels of management and the ability to produce clear, logical, and concise products.
- Proven experience with handling and delegating competing priorities, the ability to assess the significance of current developments, and the capability to brief senior consumers in a dynamically changing environment.
- Strong planning and problem-solving skills, and the ability to work independently.
