Position Information

This is an opportunity for:

- An external candidate to fill a GS - 14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade of the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre. (Current GS employees at the same grade of the advertised positions grade may apply.)



- Current Federal Government employees. (Current GS employees at the same grade as the advertised positions grade may apply.)
- Candidates outside the Federal Government.
- Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
- For a detailee assignment:
 - Current Federal Government employees at the same grade of the advertised positions grade may apply.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

Component Mission

Assist IC-CFO leadership to formulate and execute the budget for the next generation Intelligence Community Financial and Resource Management System.

Assist IC-CFO leadership with strategies for future projects.

Participate in analytic capabilities & technology, and ODNI Governance processes.

Manage and monitor AWS platforms in both JWICS (C2S), SIPR and unclassified environments.



Work with project leads to establish Program Management Reviews.

Provide oversight to the successful execution of spend plans and assess variances from cost and schedule baseline. Oversee the reallocation of resources in response to change considering impact to project cost, schedule, and quality of deliverables.

Lead or engage in the development, improvement, and implementation of financial management policies and guidelines and establish performance metrics against priorities, policies, and objectives.

Extensive experience working on complex IT projects.

Knowledge and ability to manage risk management process.

Demonstrated ability to develop or implement information systems security plans and procedures.

Extensive project management, analytic, and critical thinking skills, including the ability to conduct project and management assessments, identify needs and requirements, and develop non-linear process improvement recommendations for implementation across the IC.
