## Position Information

**This is an opportunity for:**

- An internal candidate to fill a GS-12 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply).

## Salary Determination



- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## **Component Mission**

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

## **Major Duties and Responsibilities (MDRs)**

- NCTC's Directorate of Terrorist Identities is seeking a highly motivated individual to perform mission integration --preferably with previous experience in identities intelligence and/or homeland security analysis. Possible responsibilities include:
  - Updating, correcting, and/or auditing watch listing data to meet current watch listing policies and support the needs of the nominating and screening community.
  - Resolving watch listing quality assurance issues identified by internal and external users and undertaking proactive reviews of records with specific characteristics.
  - Performing training and/or providing briefings to IC leaders as well as IC peers.
  - Applying analytic approaches and techniques to gain an in-depth understanding of complex analytical issues and incorporate into products, briefs, and/or policies.
  - Responding to DTI front office inquiries.
  - Exploiting internal and external online databases, posing and obtaining answers to questions from appropriate organizational and IC sources, and consulting with peers, colleagues, and components as necessary.
  - Establishing and maintaining effective working relationships with counterparts in the CT, intelligence, and law enforcement communities to support NCTC mission requirements and analytic undertakings and to promote intelligence integration.
  - Validating data within terrorist identity records using a variety of traditional and non-traditional intelligence sources.

## **Mandatory and Educational Requirements**

- Upon hiring, successfully complete a multi-week, hands-on Terrorist Identities Datamart Environment (TIDE) Production training program for DTI analysts.

## **Desired Requirements**



- Experience as a counterterrorism and/or identity intelligence analyst.
- Understanding current and historical international terrorist threat landscape.
- Using a variety of investigative, analytic, and travel databases.
- Ability to communicate clearly, both orally and in writing.
- Using TIDE or other identity intelligence systems.
- Quality control, quality assurance, auditing, and/or data integrity efforts.
- Instructional design degree/background.
- Knowledge in drafting and implementing policies.
