Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.)



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Mission Support Division (MSD) provides its customers with a full range of support services and integrated solutions needed to accomplish the Office of the Director of National Intelligence (ODNI) mission. MSD staff provide proactive, comprehensive support, delivered with efficiency, professionalism, and a strong focus on cost value. MSD services include Human Resources, Information Management, Information Technology and Infrastructure, National Intelligence Emergency Management Activity, Security, Counterintelligence, and Facilities Management. Major Duties and Responsibilities (MDRs)

- Provide guidance regarding the sharing and joint use of major IC facilities to improve mission effectiveness and efficiency throughout the government. Manage IC facilities and logistic projects or programs with ill-defined requirements, parallel tasks, multiple dependencies, high risks, and multiple interfaces, ensuring alignment with corporate objectives; manages the scheduling and prioritization of work tasks and critical activities for facilities and logistics programs from initiation to completion.
- Plan, manage, and coordinate multiple substantive programs for Office of the Director of National Intelligence (ODNI) Senior Executives by reviewing, researching, writing/editing, coordinating, and collaborating on time-sensitive information, correspondence, papers, policy, and briefing materials in response to taskings and action items from internal and external sources.
- Plan, manage, and coordinate strategic and tactical projects, plan and execute action taskings associated with assigned projects, and provide project status and reporting.
- Review, plan, and develop responses to email, correspondence, action items, and taskings; plan and manage priorities and response progress, coordination, and collaboration; track progress against actions from internal and external sources.
- Monitor the development of financial forecasts and budget assessments and make structured recommendations for new space allocation, construction, occupancy and logistics planning to meet ODNI mission-critical requirements.
- Monitor construction projects, contract negotiations, and manage contractual obligations as defined in associated contracts to support that program.



- Monitor the development of structured recommendations on facility operational improvements that comply with applicable Executive Orders, regulations, and statutes.
- Plan, research, write, and edit talking points, correspondence, executive summaries, communications, presentations, and briefing materials; plan and develop activity reports and summaries and edit and rewrite as necessary.
- Plan, manage, coordinate, and integrate work activities, assignments, and projects with managers internal to the ODNI and across the Intelligence Community (IC) to ensure their understanding and the effective completion of initiatives and requirements.
- Coordinate and manage SLAs and ISSAs, real estate/real property reporting requirements, and congressional notifications
- Serve as the COR for the Facilities and Logistics Office.
- Serve as the focal point to compile, review and submit responses for the FIN OPS Data Calls.

Mandatory and Educational Requirements

- Demonstrated ability to manage complex facilities and logistics programs from inception to completion.
- Demonstrated ability to plan, organize, and direct facility and logistics projects, budgets, leases, expenditures, maintenance, and repairs related to buildings.
- Demonstrated oral and written communication skills to communicate effectively with key stakeholders throughout the IC and United States Government.
- Demonstrated analytical, critical thinking, and problem solving skills, including the demonstrated ability to interpret complex information from multiple sources.
- Demonstrated interpersonal, organizational, and problem-solving skills, including the demonstrated ability to develop working relationships and networks with internal and external managers and staff.
- Demonstrated research, planning, and organization skills, and demonstrated ability to manage changing and competing priorities under strict timelines while maintaining a high level of attention to detail.
- Demonstrated ability to work effectively with ODNI leaders in a highly active, fast-paced, and demanding organization.
- Extensive knowledge of Congressional and OMB information needs and reporting requirements, capital projects, policies, processes, and procedures, as well as extensive knowledge of space management, programming, building design, construction, and maintenance.
- Demonstrated ability to develop financial forecasts, conduct analysis, and coordinate facility projects concerning space management, design, bids, awards, construction, occupancy, and warranty within the ODNI.

- COTR certification or the ability to obtain certification in 90 days.
