Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or two grades below the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.

- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or two grades below the advertised position grade may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

Major Duties and Responsibilities (MDRs)

The Directorate of Intelligence is looking for an enthusiastic and collaborative analyst to augment our effort to produce all-source strategic and tactical analysis for policy, intelligence, homeland security, and law enforcement communities to inform decision-makers. The analyst will be focused on transnational issues. This unit will inform and warn of emerging global trends in terrorist threats, terrorist travel and use of documents; terrorist weapons, explosives, and tactics; and terrorist threats to transportation and infrastructure.

This unit seeks a highly motivated individual with demonstrated subject matter expertise in explosives, improvised explosive devices, conventional infantry weapons, and/or terrorist tactics to join the Weapons and Explosives Cell within our unit. Integration and collaboration are hallmarks of NCTC's work, so we are seeking candidates who thrive on working collaboratively with colleagues across the Intelligence Community. Branch analysts write intelligence products for senior CT officials across the USG, brief policymakers and IC counterparts, and support state/local law enforcement/homeland security officers. The successful candidate will join a group with a skilled mix of employees on rotation from CIA, DHS, FBI, NGA, and NGIC, as well as ODNI staff employees. NCTC encourages its analysts to maintain and broaden their substantive and analytic expertise through training and attendance at professional meetings. Opportunities exist for domestic and foreign travel. This position is eligible for Joint Duty credit.

Major Duties and Responsibilities Include:

- Perform research on complex military, technical, intelligence, economic, political, social, cultural, or historical reports and information in support of United States (US) policy, intelligence, and military consumers.
- Perform in-depth tactical, multidisciplinary, and strategic analyses of complex and significant national, regional, and/or global issues for senior policymakers and key components in the Intelligence Community (IC), law enforcement, and the Office of the Director of National Intelligence (ODNI).
- Produce a broad range of finished intelligence products in support of US foreign policy and national security interests and anticipate and seek strategic military issues for analysis.
- Identify strengths and weaknesses of terrorist capabilities and weapons; initiate and apply alternative analysis to determine the range of possible outcomes and consider the warning implications for national security.
- Utilize a variety of methodological tools and approaches to gain a comprehensive understanding of complex analytic issues, develop and implement strategies for gathering intelligence, or historical information in support of US interests and policy objectives; cultivate and identify key internal and external sources of relevant information that meet customer and self-derived needs, and incorporate insights and findings into well-crafted, sophisticated intelligence products.
- Prepare and present written and oral briefings to senior internal and external customers on significant and complex issues; explain complex concepts to non-expert customers and tailor products to correspond to customer needs
- Maintain productive working relationships with colleagues, experts, IC members, policy committees, and law enforcement agencies as appropriate and use these relationships to share information of interest; interact regularly with foreign military, diplomatic, and intelligence experts, and attend internal and external training, seminars, or conferences on broader strategic subject areas.

Mandatory and Educational Requirements

- Extensive knowledge in area of subject matter expertise.
- Demonstrated ability to effectively plan, research, develop, and write high-quality, complex analyses, studies, projects, assignments, and briefings on key US foreign policy and national security objectives focused on a specific region or transnational issue for IC consumers and policymakers at the highest levels of government.
- Superior ability to apply expert knowledge of ODNI, IC organizations, and relevant customer organizations or operations (e.g., military, policymakers, and law enforcement), in order to effectively translate their requirements and provide appropriate output or responses to meet customer needs.
- Extensive knowledge of IC policy and procedures and demonstrated knowledge of analytic tradecraft and superior ability to communicate intelligence information and judgments to generalists as well as specialists.

- Demonstrated ability to produce analytic finished intelligence related to the subject matter issue, either as lead analyst or manager of analysts, and broad knowledge of the role of intelligence analysis within the IC.
- Demonstrated ability to lead and promote the development and use of a broad range of methodological tools and approaches to research, analyze, and present data (modeling, link analysis, or software).
- Demonstrated ability to maintain and develop regular contacts within the Office of the Director of National Intelligence (ODNI) and the IC for exchanging information.
- Demonstrated levels of flexibility and superior ability to remain open-minded and change opinions on the basis of new information and requirements; superior ability to support group decisions and solicit opinions from coworkers.
- Demonstrated ability to oversee and direct information sharing programs and promote information sharing practices across the ODNI and IC.
- Demonstrated analytic and critical thinking skills, including superior ability to think strategically.
- Demonstrated ability to execute senior-level guidance in a fast paced environment and superior ability to translate strategic goals into specific objectives with appropriate metrics and methods to track progress towards meeting those goals.
- Demonstrated interpersonal, organizational, and problem-solving skills, in working with individuals at the highest levels of the IC and government in justifying, defending, negotiating, and resolving significant and controversial issues.
- Demonstrated ability to work effectively both independently and in a team or collaborative environment, and mentor junior colleagues
- Creative problem-solving skills and initiative in carrying out mission responsibilities.
