**Position Information** 

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

### **Who May Apply**

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - o Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)

### **Salary Determination**

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or
  other Federal Government candidate will be assigned to the position at the employee's current GS grade and
  salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

\*\*\*OPEN UNTIL FILLED: This announcement will be open until the position is filled. Cut-off points are scheduled in two-week increments. After each cut-off point, all compliant applicants received during the previous two weeks will be reviewed for consideration.\*\*\*

#### **Component Mission**

National Security Partnerships synchronizes Intelligence Community (IC) support and whole of government efforts with federal, state and local governments, the private sector and the Department of Defense, ensuring IC outreach is coordinated, timely and relevant. It also provides key leadership for activities in four domains that operate across national sectors – aviation, maritime, space and cyber -- bringing the IC's activities in these domains into alignment, and facilitating coordinated engagement internal to the ODNI, across the IC and with the rest of the federal government

### Major Duties and Responsibilities (MDRs)

- Maintain effective working relationships with other ODNI and IC components and other government agencies to address issues that span multiple mission or program areas.
- Serve as the principal collection subject matter expert responsible for supporting the NIM-Cyber.
- Participate in developing, maintaining, and executing a Unifying Intelligence Strategy (UIS) for Cyber Threat Intelligence (CTI).
- Perform leadership functions in aligning and integrating the IC collection enterprise's total array of collection capabilities against the nation's most important strategic intelligence issues related to CTI.
- Partner with the Cyber community in assessing progress against key intelligence gaps of the UIS. Conceptualize, develop, analyze, and create strategic collection initiatives and requirements to ensure their alignment with National Intelligence Priorities Framework objectives, as well as ODNI and NIM-Cyber missions and goals.
- Lead, plan, and prepare briefings, reports, and presentations to organizational leadership in a manner that meets their specified requirements and provide expert opinion and recommendations related to IC CTI collection capabilities that ensure IC strategic plans and programs align with strategic objectives.

### Mandatory and Educational Requirements

- Expert knowledge of IC organizations' Cyber collection missions to develop the national-level collection strategies and policies necessary to support U.S. national security and foreign policy interests.
- Expert ability to evaluate collection-associated trends, strategy, and implementation plans, results, and programmatic data, propose innovative solutions, and implement change.
- Superior communication (written and verbal) skills to effectively and efficiently communicate organizational vision, mission, and plans.

• Extensive interpersonal, organizational, and problem-solving skills, including a demonstrated ability to develop innovative and flexible solutions for complex cross-organizational issues, taking initiative and making key contributions to group efforts.

- Expert organizational and interpersonal skills to facilitate diverse forums, manage competing priorities, and advocate new ideas/concepts/processes.
- Superior ability to exercise independent judgment on time-sensitive issues and work collaboratively across the IC.

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. Applicants from within the IC <u>must</u> submit an application through the classified <u>IC Joint Duty Program website</u>.

### Applicants from federal agencies outside the IC must provide:

- a. WRITTEN ENDORSEMENT from the employing agency concurring with the detail.
- b. **RESUME**: Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- e. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record. Please disregard if you are not a Federal Government employee.
