## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply. )



## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## Component Mission

The National Counterterrorism Center (NCTC) leads our nation's effort to combat terrorism at home and abroad by analyzing the threat, sharing that information with our partners, and integrating all instruments of national power to ensure unity of effort. The Center serves as the primary organization in the United States Government (USG) for analyzing and integrating all intelligence possessed or acquired by the USG pertaining to terrorism and counterterrorism, and its Director serves as the Counterterrorism Mission Manager. NCTC also serves as the central and shared knowledge bank on known and suspected terrorists and international terrorist groups, as well as their goals, strategies, capabilities, and networks of contacts and support. In addition, NCTC conducts strategic operational planning for counterterrorism activities, coordinating and integrating the efforts of departments and agencies across the Federal Government.

The National Counterterrorism Center (NCTC) Directorate of Intelligence (DI) was mandated by Congress to be the primary organization in the United States Government (USG) for analyzing and integrating terrorism intelligence. The DI provides senior policymakers with integrated and coordinated terrorism analysis and produces the full range of analytic product, including daily National Terrorism Bulletins, President's Daily Briefs, short-term and longer-term research, alternative analysis, community alerts, advisories and assessments.

## Major Duties and Responsibilities (MDRs)

- Lead NCTC's line of effort to engage with the technology sector through periodic unclassified production and personal engagement.
- Work closely with NCTC representatives to organize and deliver briefings for technology sector companies across the US.
- Lead the production of an authoritative, unclassified, periodic publication for private sector technology companies detailing terrorist exploitation and use of social media platforms as well as significant terrorism trends.
- Engage with key foreign partners regarding US approaches to addressing terrorist use of the Internet.
- Prepare and present written and oral briefings to senior internal and external customers on significant intelligence issues related to terrorist use of the Internet and NCTC's engagement efforts with the technology sector.
- Build and leverage diverse collaborative networks within the ODNI and across the IC; maintain productive working relationships with subject matter experts, IC members, policymakers, law enforcement agencies, and



private industry as appropriate and use these relationships to share information and coordinate analytic assessments.

- Research and prepare classified and unclassified background materials and talking points for senior government representative in support of their meetings with interagency partners and the National Security Staff. Prepare background materials, speeches, and talking points for use by senior government officials in their meetings with technology sector counterparts.
- Develop and continually expand personal knowledge in areas of expertise relevant to your work.

## **Mandatory and Educational Requirements**

A 1-2 page narrative describing the below requirements:

- Expert ability to both lead and independently perform the research, development, and production of high-quality, complex analyses, studies, projects, assignments and briefings on key US foreign policy and national security objectives for IC consumers and policymakers at the highest levels.
- Interpersonal, organizational, and problem-solving skills, including an ability to work effectively both independently and in a team or collaborative environment; creative problem-solving skills and initiative in carrying out mission responsibilities based on senior-level guidance.
- Demonstrated ability to remain open-minded and change opinions on the basis of new information and requirements; ability to support and defend group decisions and assessments, accept and incorporate feedback, solicit opinions from coworkers and collaborate on a variety of assignments.

## **Desired Requirements**

- Prior work experience or advanced academic study on terrorist use of the internet and terrorist media and messaging trends
- Prior experience working with the technology sector or performing intelligence outreach activities with private sector entities
- Expert knowledge of social media platforms and a strong understanding of digital media
