Position Information

This is an opportunity for:

- An internal or external candidate to fill a SNIS Staff Reserve Position.

This is an opportunity for a SNIS staff reserve position in the ODNI. Staff reserve appointments are time-limited appointments made for a period of up to 3 years, with a possible extension up to 2 additional years.

- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Only Senior Service (SNIS, SES, SIS, DISES, DISEL) candidates may apply. GS employees may not apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.



- Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
- Current Federal Government employees. Only Senior Service (SNIS, SES, SIS, DISES, DISEL) candidates may apply. GS employees may not apply.
- Candidates outside the Federal Government.
- For a detailee assignment:
 - Current Federal Government employees. Only Senior Service (SNIS, SES, SIS, DISES, DISEL) candidates may apply. GS employees may not apply.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Assistant Director of National Intelligence for Systems and Resource Analyses (ADNI/SRA) is the principle staff assistant and advisor to the Director of National Intelligence (DNI) on matters pertaining to program analyses, evaluation, and resource allocation through independent analyses and advice relevant to the National Intelligence Program (NIP) and the Military Intelligence Program. As the principle advisor to the DNI on these matters, the ADNI/SRA analyzes, evaluates, and provides alternative plans, programs, and budgets for DNI priority objectives, projected threats, estimated costs, and resource constraints.

Major Duties and Responsibilities (MDRs)

- As a member of the DNI senior leadership team, promote the IC vision and mission, and implement, lead, and guide the DNI's strategic intent for IC wide policies, programs and resources.
- Plan, manage and execute the mission, functions, and initiatives of the DNI and IC.
- Represent DNI positions to National policy makers, Congress, OMB and White House staff.
- Develop and support SRA policies, procedures, guidelines, rules, and standards to foster effective operation of the DNI and IC.
- Develop and execute best business practices to align and integrate support with mission directives; identify gaps and opportunities that can be leveraged throughout the ODNI, and ensure flexibility and responsiveness to support equities across the EC and Directorates.



- Foster dialogue between the ODNI and IC partners to facilitate accomplishment of mission goals, advance the Director's strategic intent, implement the strategic initiatives, and deliver effective and efficient counterintelligence initiatives.
- Lead and integrate a wide range of IC activities and projects related to IC-wide policy; strategy, plans, and requirements, and strengthen strategic partnerships, at military commands and embassies, and with domestic, Federal, and private sector partners.
- Lead and facilitate cross-departmental collaboration, strengthen internal communications and create and promote a positive and inclusive work environment. Promote the principles of professional ethics for the IC.
- Lead and exemplify the ODNI core values of Commitment, Courage and Collaboration, maximize the individual contributions of staff, and promote a commitment to diversity and opportunity.
- Lead and grow a team of expert cadre, joint duty, and contractors executing the SRA mission, successfully managing complex programs and projects that may include ill-defined requirements, ambiguity, parallel tasks, multiple dependencies, and high risks; ensure timelines, costs, deliverables, and outcomes meet DNI programmatic goals.
- Perform personnel management responsibilities with a focus on building a high performance workforce; promote team building and a collaborative work environment; ensure goals and performance objectives are understood; assess performance and provide timely feedback, recognition, and remediation.
- Manage and oversee the SRA budget and execution.

- Master knowledge of analytic, diagnostic, and qualitative techniques sufficient to identify, evaluate, and recommend appropriate solutions to resolve complex, interrelated program, budgetary, and resource management issues
- Demonstrated expertise in federal policies, portfolio development and management, and regulations relative to national security programs.
- Excellent interpersonal skills, ability to work effectively with senior leaders from inside and outside the USG, to advocate and advance ODNI policy, and to communicate, coordinate, and develop a professional network across the IC.
- Ability to coordinate complex interfaces with Office of Management and Budget, ODNI and IC components
- Comprehensive knowledge of the IC mission, objectives, policies, and current events within the IC.
- Extensive knowledge of major NIP and MIP requirements, long-term programs, funding priorities, and affordability (Major System Acquisition (MSA) and non-MSA) issues.
- Knowledge and familiarity with process and preparation of cost estimates, assessments and Statements of Capabilities



- Extensive knowledge of products and processes to include the: Consolidated Intelligence Guidance, Major Issue Studies, Strategic Evaluation Reports, Strategic Program Briefings, and Analysis of Alternatives.
- Excellent oral and written communication skills and demonstrated ability to conduct independent research, filter and synthesize data, and produce clear, logical, and concise products.
