## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI cadre.
  - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
- For a detailee assignment:
  - Current Federal Government employees.

## Salary Determination



- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of National Intelligence for Intelligence Integration (DDNI/II) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. DDNI/II is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DDNI/II is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DDNI/II is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

## Major Duties and Responsibilities (MDRs)

- Manage programmatic operations of the NIM Near East office and liaise with senior IC and policymaker officials to ensure strategic alignment and direction with the ODNI staff and IC mission enterprise.
- Manage IC's response to taskings from the National Security Council including Deputies Committee, Principals Committee, and National Security Council meetings to ensure requested deliverables meet policymaker requirements.
- Support senior ODNI and DDII leadership requirements including taskings, briefings, talking points, and policymaker meeting preparations.
- Foster and cultivate strategic alliances and professional networks with interagency partners and other community elements to facilitate priority attention on National Intelligence Strategy, and Intelligence Reform and Terrorism Prevention Act (IRPTA) requirements.
- Lead interagency working groups and cross-agency collaboration to address high-priority intelligence topics; work effectively with both analysts and collectors to advance policymaker priorities.
- Maintain situational awareness of significant issues affecting NIM Near East and the broader community and alert senior NIM Near East and ODNI / DDNI/II staff regarding emerging issues.
- Help manage the IC's relationships with foreign partners regarding Near East issues by crafting sharing guidelines that meet policymaker guidance; engage with visiting liaison partners and propose topics of discussion for senior-level exchanges.
- Lead the development and preparation of internal and external memoranda and other correspondence to include policy analysis documents in response to policymaker taskings.
- Brief senior IC leadership, Department of Defense officials, members of Congress, policymakers, and other major stakeholders as necessary on NIM Near East initiatives and IC activities.
- In times of crisis, manage the IC's response to various taskings, as well as foreign and public releases of information.
- Represent NIM Near East in his/her absence at internal and external meetings, conferences, and public engagements.
- Lead assessments to leverage best practices and lessons learned.

## Mandatory and Educational Requirements



- Expert knowledge of the Middle East-North Africa region, including either formal education, professional experience, and/or familiarity with the region.
- Expert knowledge of IC members; their missions, structures, capabilities, processes, policy development, and tradecraft programs.
- Expert knowledge of IC analysis (writing and tradecraft), collection, and mission management activities across all intelligence disciplines.
- Superior analytical and critical thinking skills, including the ability to think strategically, identify needs and requirements, develop recommendations, and evaluate outcomes against goals and objectives.
- Exceptional leadership skills; ability to lead interagency working groups and initiatives to synchronize and advance the IC's mission of Intelligence Integration.

## Desired Requirements

- Superior interpersonal, organizational, and problem-solving skills, including superior ability to work effectively both independently and in a team or collaborative environment; and to lead and mentor junior colleagues.
- Superior ability to communicate, both verbally and in writing, complex information in a clear, concise manner that is targeted to and meets the needs of diverse audiences with different perspectives and objectives.
- Superior ability to listen to, clarify, and convey understanding of others' ideas, comments, and questions as well as to integrate and build upon diverse opinions in a manner that encourages the formation of integrated solutions and positions.

clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. **Applicants from within the IC must submit an application through the classified [IC Joint Duty Program website](#).**

**Applicants from federal agencies outside the IC** must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required if the applicant is unable to provide the two most recent evaluations.
- d. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- e. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record.
