Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Previous applicants need not reapply; they will be considered.

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of National Intelligence for Intelligence Integration (DDNI/II) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. DDNI/II is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DDNI/II is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DDNI/II is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

- Initiate, cultivate, and maintain productive working relationships with peers and senior leaders across the IC working issues related to the AOR in order to integrate and coordinate the NIM's mission strategy in support of U.S. policy objectives impacting the relevant region or issue.
- Assist NIM in integrating the IC's intelligence engagement in the relevant region; provide guidance and oversight to the IC on policymaker direction regarding intelligence relationships; coordinate IC strategic partner engagement with IC stakeholders for the NIM Office.
- Draft internal and external memoranda and other correspondence to include policy analysis documents in response to policymaker requirements.
- Lead interagency collaboration to address high-priority intelligence topics when necessary.
- Maintain situational awareness and develop expertise on significant issues in the AOR affecting NIM equities and the broader community and alert the NIM and ODNI/DDII staff regarding emerging issues.
- Support NIM participation in high level policy meetings with talking points, background information, and the results of relevant engagements IC agencies.
- Liaise with the appropriate Combatant Commands and the Joint Special Operations Command to maintain awareness of their operations in the region and their potential effects on intelligence interests.
- Support briefings to senior IC officials and other major stakeholders collaboration progress, issues and challenges.
- Engage counterparts on tactical coordination issues for effective implementation flagship collaboration initiatives.

Mandatory and Educational Requirements

- Demonstrated oral and written communication skills, including demonstrated ability to draft and edit written reports and talking points of varying length and complexity, and to communicate effectively with audiences of varying seniority and expertise.
- Demonstrated analytical and critical thinking skills, including the demonstrated ability to think strategically, identify needs and requirements, develop recommendations, and evaluate outcomes against goals and objectives.



- Demonstrated interpersonal skills and superior ability to work effectively in both independent settings and in a team or collaborative environment.

Desired Requirements

- Extensive knowledge of IC organizations; IC mission posture, structures, capabilities, processes, and policy development.
- Demonstrated ability to anticipate issues relevant to the IC and United States Government and recommend/implement needed actions.
- Knowledge of and experience working on countries in the Near East AOR, to include Iran.
