Position Information

This is an opportunity for:

- An internal candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI cadre.
 - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)



- For a detailee assignment:
 - Current Federal Government employees.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Civil Liberties and Privacy Office (CLPO) implements the responsibilities of the Civil Liberties Protection Officer under applicable laws, executive orders, directives, and policies, including Section 103D of the National Security Act, Section 1062 of the Intelligence Reform and Terrorism Prevention Act, and EO 12333. Specifically, the CLPO's mission includes to oversee compliance by the Office of the Director of National Intelligence (ODNI) with the constitution, all laws, Executive Orders, and implementing guidelines relating to civil liberties or privacy; ensure the protection of civil liberties and privacy is appropriately incorporated in policies and procedures developed and implemented by the ODNI and elements of the Intelligence Community (IC); ensure that the use of technologies sustain, and do not erode, privacy protections regarding the use, collection, and disclosure of personal information; ensure adequate procedures to receive, respond to, investigate, and redress privacy and civil liberties complaints; assess – and as appropriate, investigate – complaints and other information indicating possible abuses of civil liberties and privacy in the activities of the ODNI; conduct privacy impact assessments and ensure that personal information contained in a system of records subject to the Privacy Act is handled in compliance with fair information practices set out in the Privacy Act; review ODNI actions, policies, guidelines, and their implementation; and perform other duties as assigned by the DNI.

Major Duties and Responsibilities (MDRs)

- Analyze, evaluate, and inform findings, conclusions and policy recommendations relating to or impacting civil liberties and privacy.
- Identify and address civil liberties and privacy issues impacting ODNI and IC policies, programs, and activities.
- Conduct civil liberties assessments and provide structured recommendations for policies, procedures, and standards of operations.
- Provide legal counsel to support the development, review, and preparation of United States (US) Government-wide and IC-wide policies, procedures, guidelines, rules, and standards.
- Provide briefings to support ODNI and IC views on particular matters to Executive Branch entities, Congress, and private sector entities; cogently brief senior ODNI leaders on legal issues that relate to or effect ODNI and IC activities.



- Assist with policy development, clarification, and privacy protection implementation initiatives to ensure compliance with applicable laws, regulations, and other IC policies.
- Represent CLPO at meeting, conferences, and other public fora to exchange knowledge and encourage collaboration regarding civil liberties issues.
- Conduct or direct legal research and analysis on complex or sensitive legal issues as well as on laws, regulations, and policies that have an impact on ODNI and IC interests and brief ODNI leadership on issues and findings.
- Provide reviews of planned ODNI and IC activities for compliance with the US Constitution and laws of the US, Executive Orders, and other applicable regulations and policies affecting ODNI and the IC and brief ODNI leaders on potential legal and policy issues, and develop solutions to address legal problems having potential high-level impact on the ODNI's or the IC missions or activities.

Mandatory and Educational Requirements

- Extensive knowledge of laws, regulations, policies, procedures, EOs, implementation guidelines, rules, and agreements relating to federal privacy and civil liberties.
- Extensive knowledge of the IC, Executive Order 12333, the United States Constitution.
- Extensive knowledge of international, state, and local privacy and civil liberties issues, including the ability to analyze information and database technologies that may implicate privacy protections.
- Superior ability to develop and implement civil liberties and privacy compliance activities, programs, and fact-finding or investigative methods.
- Extensive knowledge of research methodologies and legal practices to conduct research, form objective conclusions, analyze issues, evaluate then draft findings and assessments, and make recommendations based on facts and evidence.
- Extensive interpersonal and organizational skills with proven ability to effectively manage the implementation of multiple projects and competing priorities.
- Superior oral and written communication skills, including the ability to produce clear, logical, and concise products that are targeted to and meets the needs of diverse audiences with different perspectives and objectives.
- Superior ability to exert influence with senior leadership and communicate effectively with people at all staff levels, both internal and external to the organization.
- Superior analytic and critical thinking skills, including the ability to conduct assessments, to identify issues and to develop process improvement recommendations.
- Superior skill in negotiating and consulting and superior judgment in applying principles to identify and solve problems.

Desired Requirements

- Completion of a Doctorate of Jurisprudence or Bachelor of Laws degree from an American Bar Association-accredited law school, and active membership of the Bar of the highest court of a US State, Territory, Commonwealth, or the District of Columbia.
- Knowledge of applicable federal laws, Presidential Directives, Executive Orders, and IC Directives affecting diplomatic security, technical security, physical security, cyber security, and counterintelligence awareness at overseas posts.
