Position Information

This is an opportunity for:

- An external candidate to fill a GS -13 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre. (Current GS employees at the same grade as the advertised positions grade may apply.)



- Current Federal Government employees. (Current GS employees at the same grade as the advertised positions grade may apply.)
- Candidates outside the Federal Government.
- Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
- For a detailee assignment:
 - Current Federal Government employees at the same grade as the advertised positions grade may apply.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

Component Mission

The Office of the Director of National Intelligence (ODNI) Chief Operating Officer (COO) has the responsibility for advising the Director of National Intelligence (DNI) and administering the DNI's vision and direction to the ODNI enterprise. This includes synchronizing policy, plans, procedures, and cross-functional issues. The COO is responsible for integrating the ODNI staff to execute all missions and tasks designated by the DNI and the Principal Deputy Director of National Intelligence (PDDNI), and for overseeing the internal management of the ODNI.

The COO oversees all ODNI business operations, including such areas as human resources, diversity & inclusion, finance and budget, information technology, security, facilities, and information management. The COO is also responsible for ODNI's emergency planning.

The mission of the Office of Counterintelligence and Security (CI&SEC) is to support the ODNI workforce with training and processes related to Counterintelligence, Security, and Insider Threat issues. CI&SEC protects the ODNI mission, personnel, information, facilities, and ultimately, national security while overcoming security and counterintelligence challenges to enable intelligence community integration.

Major Duties and Responsibilities (MDRs)

Perform in-depth analyses of complex and significant national, regional, and/or global issues for senior policymakers and key components in the Intelligence Community (IC), law enforcement, and the Office of the Director of National Intelligence (ODNI).

Oversee and coordinate analytic support related to counterintelligence, insider threat or security issues impacting ODNI personnel, resources, and equities.



Develop analytic plans and deconflict tasks among analytic support officers.

Oversee the gathering and analyzation of information from multiple databases and sources.

Make initial recommendations for action to CI&SEC leadership on CI, Insider Threat, or Security issues.

Maintain all appropriate reports and tracking mechanisms on analytic efforts and internal processes.

Collaborate with CI&SEC colleagues to inform training, policy recommendations, and regular ODNI reporting requirements.

Review and write drafts of talking points, correspondence, executive summaries, communications, presentations, and briefing materials; prepare activity reports and summaries.

Mandatory and Educational Requirements

Thorough knowledge of ODNI counterintelligence and security authorities and responsibilities.

Ability to lead an analytic team, with excellent oral and written communication skills to report and document analytic conclusions.

Demonstrated analytic core skills, including analyzing and interpreting complex all-source intelligence for nonexpert customers, briefing, and crafting sophisticated written production, or related transferrable skills.

Ability to maintain and safeguard sensitive information, carrying out job responsibilities with the utmost discretion.

Strong analytic and critical thinking skills, including an ability to think strategically and initiate analytic deliverables.

Demonstrated analytical, critical thinking skills, and problem-solving skills, including the ability to interpret complex information from multiple sources.

Desired Requirements

Prior experience in counterintelligence or security analysis.

Willingness to pursue certification as a counter insider threat analytic professional.

- Successful completion of CI polygraph and background investigation.
- Successful completion of an ODNI medical screening.
- A two-year trial period is required for all new permanent appointments to the ODNI.

- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
