## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

## Component Mission

The Office of the Director of National Intelligence (ODNI) Chief Operating Officer (COO) has the responsibility for advising the Director of National Intelligence (DNI) and administering the DNI's vision and direction to the ODNI enterprise. This includes synchronizing policy, plans, procedures, and cross-functional issues. The COO is responsible for integrating the ODNI staff to execute all missions and tasks designated by the DNI and the Principal Deputy Director of National Intelligence (PDDNI), and for overseeing the internal management of the ODNI.

The COO oversees all ODNI business operations, including such areas as human resources, diversity & inclusion, finance and budget, information technology, security, facilities, and information management. The COO is also responsible for ODNI's emergency planning.

## Major Duties and Responsibilities (MDRs)

Work on matters pertaining to day-to-day operations and the full life-cycle of contracting from planning and execution to contract administration and support of core mission functions.

Serve as a Contracting Officer responsible for award and administration of FAR and non-FAR based contracts (Other Transaction Agreements) and Federal Assistance agreements (grants and cooperative agreements) with an emphasis on FAR Part 35 R&D.

Award and administer contracts and financial assistance agreements to include source selection, sole source approval, contract/agreement negotiation, changes and modifications, performance monitoring, compliance with terms and conditions; resolving disputes; and contract/agreement closeout.



Perform detailed cost and price analysis to ensure cost/price reasonableness and provide business and financial advice to senior management.

Assist and advise Program Managers (PMs) to define requirements and collaboratively work with PMs to plan, develop and establish strategies for obtaining each requirement.

Handle complex issues including selection of contract type, intellectual property and data rights, export control, competitive source selection, unique contract requirements, subcontract review and approval, organizational conflicts of interest mitigation, transfer and disposition of Government property.

## **Mandatory and Educational Requirements**

Thorough knowledge of contract vehicles to include, independent contractor, commercial item acquisitions, firm fixed price, and indefinite delivery indefinite quantity, and cost reimbursement.

Progressively responsible experience that provided knowledge of Federal Acquisition Regulations principles, concepts, and practices, reform initiatives, and policies and procedures, and demonstrated ability to effectively apply these laws, regulations and procedures to determine contracting methods, types of acquisition instruments, business and negotiation strategies, techniques of cost analysis, and determination of contractor responsibility, methods of monitoring the performance of long term contracts and agreements with multiple partners, and contract and agreement administration.

Currently serves as a warranted contracting officer or has served as a warranted contracting officer within the last 2 years, with proven technical competencies to conduct a wide range of acquisition life cycle activities from acquisition planning through contract award and subsequent closeout activities.

DAWIA, FAC-C Certification or other equivalent certification in Contracting.

Thorough knowledge of requirements sufficient to work with technical representatives in defining needs.

Demonstrated customer service and business advisory skills.
