## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade or one grade lower as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

## Major Duties and Responsibilities (MDRs)

Support the Intelligence Community (IC) program and resource allocation process by collaborative developing programmatic guidance for activities funded by the National Intelligence Program (NIP) and Military Intelligence Program (MIP).

Facilitate and track the status of IC implementation of activities directed by programmatic guidance.

Assess IC progress in achieving Strategic Objectives from the National Intelligence Strategy and Strategic Outcomes directed by the Consolidated Intelligence Guidance.

Lead, plan, support, and author assessments, reports, talking points, briefings, and other products to present findings, conclusions, options, and recommendations to ODNI and IC senior management, applying extensive subject matter knowledge and data visualization methods to support IC senior leaders in making informed programmatic decisions.

Collaboratively support the DNI through managing Strategic Program Discussions (SPDs) with IC Programs, which will include a strategic dialogue with senior IC leadership on intelligence priorities, needs, outcomes, resources, and budget priorities.

## Mandatory Requirements

Extensive experience working with ODNI and/or other IC organizations, and expert knowledge of multiple intelligence disciplines, intelligence systems and capabilities, intelligence missions (regional and functional).

Experience with developing strategic planning and guidance, expert knowledge of methods used to evaluate organizational performance against strategic objectives, and experience with applying quantitative and qualitative analytic techniques to evaluate complex issues and recommend appropriate alternatives.



Superior organizational and interpersonal skills, including ability to establish, lead, and support collaborative teams, foster a collaborative work environment, and to develop and leverage effective relationships with peers and colleagues in the ODNI and with IC partners to effectively coordinate and collaborate on work tasks and build consensus on contentious issues.

Superior ability to work effectively with senior leadership.

Superior ability to communicate, orally and in written form, complex information in a clear, concise manner that is targeted to and meets the needs of diverse audiences with different perspectives and objectives.

Ten or more years of experience working in a national or military intelligence organization, especially in strategic planning, resource management, intelligence analysis, or working with intelligence systems.

Master's degree preferred; Bachelor's degree required.

## Desired Requirements

Expert knowledge of and experience working with intelligence resource management processes.

### Current Federal Employees Applying for a Detail Assignment:

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees. **Applicants from within the IC must submit an application through the classified IC Joint Duty Program website.**

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **VACANCY NUMBER:** Reference the vacancy number in the subject line of the email and on each document submitted.
- e. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record. Please disregard if you are not a Federal Government employee.
- f. **COVER LETTER:** Applicants must submit a cover letter as a supplement to the resume to elaborate on their qualifications and previous work performed.
