Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

For a cadre assignment:

- Current ODNI permanent cadre.

For a detailee assignment:

- Current Federal Government employees at the same grade or one grade lower than the advertised grade may apply.



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail assignment, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

Lead and execute the creation, coordination, and publication of formal and informal collection management and prioritization products related to the Near East, in collaboration with other ODNI and IC elements.

Work collaboratively within NIM-Near East and across other ODNI elements to drive the development of intelligence collection strategies for the Near East region, including through the Unifying Intelligence Strategy process, evaluate their progress, and develop options to overcome obstacles.

Develop integrated collection strategies for respective mission areas. Conduct analysis and provide recommendations on "cross-target tradeoffs."

Guide the IC's development and oversee the NIM-Near East team's evaluation of collection proposals for Near East Joint Hard Target Strategies and other NIM-led collection initiatives.

Lead the IC to remain current with major technical developments and with other IC programs in areas of interest.

As the lead NIM-Near East NICO, develop and implement the strategic direction for Near East collection portfolio and the NIM-Near East NICO team.

Mentor and facilitate the professional development of other members of the NIM-Near East team and the wider ODNI NICO community.

Lead the development and implementation of building a culture to deliver services that exceed customer expectations.

Build and maintain a network of ODNI and IC colleagues with the functional and regional expertise necessary to enable timely and thorough execution of the NIM-Near East mission.

Support briefings to senior IC officials and other major stakeholders collaboration progress, issues and challenges.



Create and sustain partnerships with other IC elements.

Maintain effective working relationships with other ODNI and IC components and other government agencies to address issues that span multiple mission or program areas.

Mandatory and Educational Requirements

Expert knowledge of IC collection systems and capabilities, collection management processes and systems, and intelligence prioritization processes (e.g. National Intelligence Priorities Framework), and their application to Near East intelligence issues.

Superior interpersonal skills and ability to work effectively in both an independent capacity and a team or collaborative environment.

Superior oral and written communications skills, including superior ability to draft and edit written reports of varying length and complexity under tight deadlines, and to communicate effectively with audiences of varying seniority and expertise.

Desired Requirements

Superior ability to manage strategic and tactical level topics, and develop innovative recommendations and solutions for improvement.

Superior ability to anticipate issues relevant to the IC and United States Government and take the initiative to recommend and implement needed actions.

Applicants must have current TS/SCI clearances with polygraph or have the ability to obtain one. The ODNI does not conduct polygraphs or provide security clearances for detailees.

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required in the cover letter if the applicant is unable to provide the two most recent evaluations.
- d. **POSITION NUMBER:** Reference the position number in the subject line of the email and on each document submitted.
- e. **CURRENT SF-50:** Federal Government employees must provide an SF-50, "Notification of Personnel Action" to verify current federal status, position, title, grade, and organization of record. Please disregard if you are not a Federal Government employee.
