Position Information

This is an opportunity for:

- An external candidate to fill a GS-14 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre. (Current GS employees at the same grade or one grade below the advertised positions grade may apply.)



- Current Federal Government employees. (Current GS employees at the same grade or one grade below the advertised positions grade may apply.)
- Candidates outside the Federal Government.
- For a detailee assignment:
 - Current Federal Government employees at the same grade as the advertised positions grade may apply.

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of Mission Integration (MI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. MI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, MI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. MI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

Assist in staffing Office of the Director of National Intelligence (ODNI) participation in coordinated foreign intelligence relationship activities, primarily in concert with National Intelligence Managers. Work closely with other NIMC and ODNI staff to provide support for DNI and PDDNI foreign travel and visits with interlocutors.

Contribute to cultivating and maintaining productive working relationships with peers and partners across the ODNI and IC. Promote increased trust and collaboration among ODNI directorates and components with respect to staffing processes for DNI and PDDNI foreign visits and travel.

Assist in NIMC implementation of strategic assessments of the effectiveness and potential of key foreign intelligence partnerships. Demonstrate commitment to following best practices for how FPG should collaborate with the regional NIMs to advance foreign engagement strategies.

Complete assigned staff actions and ODNI internal and external taskings pertaining to partner relationships in a timely manner; participate in partner meetings, interagency forums, and special events, and address questions about partner relations.



Mandatory and Educational Requirements

Experience with and knowledge of the IC, intelligence policy, intelligence operations, and foreign affairs situational awareness.

Interpersonal, organizational, and problem-solving skills, including demonstrated ability to work effectively both independently and in a team or collaborative environment.

Ability to communicate complex information clearly and concisely to diverse audiences.

Desired Requirements

Experience supporting foreign intelligence relationship development activities and efforts; experience in the Africa region beneficial.

Experience working directly with foreign liaison partners.

Demonstrated experience supporting senior IC or DoD leader foreign engagement activities and efforts.
