Position Information

This is an opportunity for:

- An internal candidate to fill a SNIS Professional Tier 1 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Senior Service (SNIS, SES, SIS, DISES, DISEL) candidates may apply. Highly qualified GS-15 candidates may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. Senior Service (SNIS, SES, SIS, DISES, DISEL) candidates may apply. Highly qualified GS-15 candidates may apply.

Salary Determination



- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI), Directorate for Mission Integration (DMI) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the Intelligence Community (IC) enterprise. DMI is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DMI is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DMI is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components in support of the National Intelligence Managers (NIMs) and to advance the Unifying Intelligence Strategies (UIS). The National Intelligence Council (NIC) consists of the most senior intelligence analysts supporting the Director of National Intelligence (DNI) in carrying out responsibilities as the head of the Intelligence Community (IC) and as the principal adviser to the President for intelligence matters related to national security. The NIC produces a variety of all-source, IC coordinated intelligence reports, including its flagship product, the National Intelligence Estimate, which represents the Intelligence Community's most authoritative statement on a key national security issues.

Major Duties and Responsibilities (MDRs)

- Support the NIO in all aspects of his/her role as the IC's senior analytic expert on East Asia. Represent the NIO East Asia in his/her absence at internal and external fora and outreach activities.
- Plan and manage production of strategic analysis and analytic policy support on East Asia issues for the DNI, National Security Council, top policymakers and military officials, and Members of Congress.
- Orchestrate and direct Community-wide and long-term strategic analysis of East Asia issues; lead and oversee the preparation, production, coordination, and dissemination of National Intelligence Estimates, Intelligence Community Assessments, Sense of the Community Memoranda, and other NIC products.
- Provide expert assessments on analysis regarding East Asia affairs; prepare and coordinate background papers and briefing books for the DNI and Principal Deputy Director of National Intelligence (PDDNI).
- Lead, manage, and direct a professional level staff, evaluate performance, collaborate on goal setting, and provide feedback and guidance regarding personal and professional development opportunities; manage contracting staff and oversee and manage the NIO/East Asia Program of Analysis and budget.
- Review Community research and production plans on East Asian issues; identify redundancies and gaps; and advise the NIO on gaps and shortfalls in capabilities across the IC.
- Establish and sustain networks with IC analysts, analytic managers, and collection managers to ensure timely and appropriate intelligence support to policy customers.



- Brief senior IC members, policy makers, military decisions makers, members of Congress, and other major stakeholders as necessary.
- Establish and foster liaison relationships with foreign partners, academia, thinktanks, and other non-government subject matter experts to ensure the IC has a comprehensive understanding of East Asian issues.
- Lead and oversee the preparation of correspondence and/or products in response to congressional tasking, including testimony, talking points, and statements for the record for the DNI and senior DNI staff.
- Create and sustain partnerships with other IC elements.

Mandatory and Educational Requirements

- Recognized expertise in East Asian regional analysis and knowledge of the IC's East Asian regional analytic community and collection issues sufficient to lead the IC's analytic production.
- Demonstrated capability to direct interagency, interdisciplinary IC teams against a range of functional and/or regional analytic issues.
- Excellent interpersonal, organizational, and management skills to conceptualize and effectively lead complex analytic projects.
- Expert leadership and managerial capabilities, including the ability to effectively direct taskings, assess and manage performance, and support personal and professional development of all levels of personnel.
- Ability to work with and fairly represent the IC when analytic views differ among agencies.
- Excellent communication skills, including ability to exert influence with senior leadership and communicate effectively with people at all staff levels, both internal and external to the organization, to give oral presentations and to otherwise represent the NIC in interagency meetings.
- Proven critical thinking skills and the ability to prepare finished intelligence assessments and other written products with an emphasis on clear organization, concise, and logical presentation.

Desired Requirements

- Proficiency at Reading level 3 is desired in any of the following languages: Chinese (Mandarin), Japanese.
- A selected candidate who has the desired foreign language capability may qualify for language use pay in the ODNI if he or she has current test scores at the minimum proficiency levels in each modality as specified. If qualified, the ODNI will provide language use pay at the rate applicable to the parent agency.

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.

- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required if the applicant is unable to provide the two most recent evaluations.
