Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or one grade lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)



Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Office of the Director of National Intelligence (ODNI) Deputy Director of National Intelligence for Intelligence Integration (DDNI/II) serves as the Director of National Intelligence's (DNI) senior leader for intelligence integration across the IC enterprise. DDNI/II is responsible for ensuring customer outcomes by leading advances in collection and analysis that ensure the quality, timeliness, and utility of insights for the nation's decision-makers. Additionally, DDNI/II is responsible for increasing expertise and improving tradecraft at all levels through specialization, integration, and collaboration. DDNI/II is responsible for the strategic vision, direction, and planning to deliver a more integrated IC reflecting the collective wisdom of our collection and analytic components to advance, in support of the National Intelligence Managers, the Unifying Intelligence Strategies (UIS).

Major Duties and Responsibilities (MDRs)

- Serve as the collection subject matter expert supporting the DMI and the National Intelligence Manager (NIM) for Russia, Europe, and Eurasia (REE) in developing collection initiatives, aligning resources, managing priorities, and assessing capabilities and challenges.
- Advise the DMI and NIM-REE on collection capabilities and trade-offs.
- Partner with the IC in advancing the collection mission and assessing progress against key intelligence gaps identified in the Unified Intelligence Strategy (UIS).
- Lead the integration and alignment of all collection capabilities within the ODNI and other collection agencies against the most important strategic intelligence issues within the NIM-REE mission areas.
- Balance long-term, enduring requirements against current issues and trade-offs while also documenting opportunity costs across the collection enterprise, in support of the NIM-REE's goals and requirements.
- Support the development of fiscal year budget builds and other budget matters in support of IC collection initiatives related to the NIM-REE AOR.
- Partner with MPAC to support assessments of collector performance through active participation in the Collection Platform Value Assessment and the Integrated Mission Strategy lines of effort.
- Partner with other NICO's to de-conflict collection priorities, integrate strategies across NIM AORs, and align resources.
- Develop integrated collection strategies for respective mission areas. Conduct analysis and provide recommendations on "cross-target tradeoffs".



Mandatory and Educational Requirements

- Expert knowledge of and broad experience with addressing intelligence collection-related issues, and in-depth expertise on intelligence collection activities, capabilities, programs, and organizations.
- Demonstrated expertise in developing near- and long-term collection strategies, setting goals, establishing metrics, overseeing projects and initiatives, and measuring progress.
- Superior oral and written communication skills, including superior ability to draft and edit written reports of varying length and complexity, and to communicate effectively with audiences of varying seniority and expertise.

Desired Requirements

- Prior experience with multiple intelligence source disciplines and working in a cross-domain environment.
- Prior work experience focused on both functional and regional issues related to Europe.
- Prior experience working with DoD combatant commands, DEA, DHS, FBI, and IC agencies, NT-50 organizations, and foreign partners.

The ODNI does not conduct polygraphs or provide security clearances for detailees. **Applicants from within the IC must submit an application through the classified [IC Joint Duty Program website](#).**

Applicants from federal agencies outside the IC must provide:

- a. **WRITTEN ENDORSEMENT** from the employing agency concurring with the detail.
- b. **RESUME:** Applicants are encouraged to carefully review the vacancy announcement, particularly the MDRs, and construct their resume to highlight their most significant experience and qualifications relevant to this job opportunity.
- c. **PERFORMANCE EVALUATIONS:** Applicants are required to provide their two most recent performance evaluations. A justification is required if the applicant is unable to provide the two most recent evaluations.
