## Position Information

This is an opportunity for:

- An internal candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

## Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
  - Current ODNI permanent cadre.
- For a detailee assignment:
  - Current Federal Government employees. (Current GS employees at the same grade as the advertised position grade may apply.)



## **Salary Determination**

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

## **Component Mission**

The Director of National Intelligence (DNI) serves as the head of the Intelligence Community (IC). The DNI also acts as the principal advisor to the President and the National Security Council for intelligence matters related to national security; and oversees and directs the implementation of the National Intelligence Program. The DNI leads intelligence integration and forges an intelligence community that delivers the most insightful intelligence possible.

The Deputy Director of National Intelligence for Enterprise Capacity (DDNI/EC) is responsible to the DNI for all matters pertaining to IC resources, workforce, systems, technology and infrastructure, with five reporting components: Acquisition, Procurement and Facilities, IC Chief Financial Officer, IC Chief Human Capital Officer, IC Chief Information Officer, and Systems & Resource Analyses.

The Director of National Intelligence (DNI) serves as the head of the Intelligence Community (IC). The DNI also acts as the principal advisor to the President, the National Security Council, and the Homeland Security Council for Intelligence matters related to the national security; and oversees and directs the implementation of the National Intelligence Program. The Intelligence Community (IC) Chief Information Office is responsible for advancing the Intelligence Community's mission by driving secure collaboration, integration, and information sharing; identifying and addressing information enterprise risks; and providing strategic leadership and oversight of the Intelligence Community's enterprise architecture and enterprise information technology.

## **Major Duties and Responsibilities (MDRs)**

- The IC Architecture, and Integration Division (AID) provides executive management and leadership for architecture, engineering and integration functions incorporating activities required to collaborate with IC CIO, ODNI, and IC Agency organizations to plan, organize, direct, and implement enterprise, reference and data architectures, systems engineering and integration practices. AID is functionally organized across the main lines of business:
- Enterprise Architecture Group (EAG) – Leads development and implementation of the IC Enterprise Architecture and supporting products to include Reference Architectures.
- Needs and Requirements Process– Engages with partners to identify validated IT needs and drives the IT needs-to requirements towards mission outcomes in the IC IE
- Integration Engineering Group (IEG) – Conducts systems engineering and interoperability assessments
- Standards and Compliance Group (SCG) – Develops interoperability standards and specifications; oversees compliance Architectures; and performs verification and EA certification (in accordance



with federal law) of agency and Services of Common Concern (SoCC) compliance (EA, Standard, Policy, etc.) In coordination with the Director, AID, the Deputy Director shall;

- Lead a team of professional staff and assess performance, collaborate and oversee goal setting, and provide feedback on personal development.
- Lead, direct and manage the planning, organizing, coordination, and implementation of the enterprise architecture, systems engineering, and integration practices to foster a secure, interoperable and effective IC Information Environment (IE).
- Provide senior IC Leadership with guidance, and expert advice in developing, promoting, and maintaining the successful design and integration of the overall IC IE, with a particular emphasis on building an interoperable, secure and responsive IC Information Environment, enabling mission efficiencies and effectiveness.
- Represent the Office at AID-related fora conducting ongoing collaboration and outreach with stakeholders and partners across the ODNI, IC, Department of Defense, US Government, and oversight organizations (e.g., Congress and OMB), as needed, to meet mission objectives.

- Excellent organizational, managerial, and leadership skills, including ability to effectively manage the professional development of staff employees.
- Expert ability to quickly identify and apply new technologies, methodologies, and technical languages.
- Expert experience in cross community complex programs and making expert recommendations to improve products and services; considerable ability to deal with service failures and prioritize customer needs.
- Expert knowledge of design, development, and interconnectivity in problem analysis, structured analysis and design, and or programming techniques.
- Expert knowledge of one or more computer disciplines/specialties (hardware, software, networks); broad knowledge of other related disciplines.
- Extensive briefing and communication skills with the ability to effectively communicate complex issues, analytical results and recommendations in a clear and concise manner to senior leadership.
- Outstanding interpersonal skills and the ability to build consensus, work effectively and independently, and influence key stakeholders to build a broad coalition promoting an interagency strategic objectives.
- Proven ability to work with senior officials, to build and sustain professional networks in a diverse, fast-paced, multi-task environment, and to manage competing priorities.
